

23 MILLION BOOKS & COUNTING



In 2022, Bernie's Book Bank distributed our **23 MILLIONTH book**, a metric that is both humbling and inspiring. By partnering with 900+ Title I Schools and early childhood programs, 300,000 children across the city of Chicago, and Cook, DuPage, Kane, Lake, McHenry and Will counties, each received a bag of 8 books.

Our organization proudly distributed **90,000+ bilingual/Spanish books** in 2022, including a custom print run of "Isabel & her Colores Go To School" by Alexandra Alessandri. This book exemplifies our Book Philosophy which mandates each bag of books contain titles that are age-appropriate, high-quality and culturally relevant. Bernie's Book Bank believes in providing children **free access to developmentally appropriate books** that will engage them by reflecting their own lives and providing insight into a full range of human experiences. This concept, as articulated by Dr. Rudine Sims Bishop in her "Mirrors, Windows and Sliding Glass Doors" speech, is reflected in our Book

Philosophy. Every bag distributed contains a variety of fiction and non-fiction titles, including picture and chapter books, graphic novels, mysteries, biographies, science fiction, sports, science, technology, and more. Every book distributed is vetted by dedicated volunteers and the Bernie's Book Bank team.

A BRIGHT FUTURE

As Bernie's Book Bank enters our 14th year, we reflect on our success to date and acknowledge that there is still work to do.

Our goal is to serve as many children as possible. By leveraging data to pivot to a more efficient distribution model in 2022, we made great strides toward this goal. Distributing books once annually with partners, instead of twice, enables our distribution team to visit more Title I schools and Early Childhood Programs each year, and allows more time to pick up donated books.

As a result of these changes in 2022, and generous support from our donor base, we transitioned numerous schools off of our waiting list.

More than 50,000 children who had been waiting for books since 2017, 2018 and 2019 are now building their own personal libraries. This is a major milestone as we focus on serving every eligible child in Chicago and look towards national expansion.

EFFICIENCY SCALED



Processing more than 2.3 MILLION books requires efficiency, accuracy and dedication. In 2022, Bernie's Book Bank scaled all three elements. With the support of Zebra Technologies scanners and a custom database developed by the Bernie's Book Bank team, books can be sorted by age level with greater precision and less time. Dedicated volunteers using scanners can now process almost twice as many books per session. The increase in accuracy and decrease in time required to conduct quality control

frees up team members who can now manage 4-5 times more volunteers per session. With three sessions daily, six days a week, Bernie's Book Bank hosted more than 30,000 volunteer hours in 2022. Overall our capacity has increased by 8 to 10 times, which positions the organization for success in 2023 and beyond.



INTRODUCING BOOKAPALOOZA

The inaugural Bookapalooza took place in Cornell Square Park on Saturday, July 16, 2022. Inspired by our successful StoryBook Festival, Bookapalooza celebrated the magic of children's books for local families. Attendees enjoyed interactions with book characters, games, literacy activities, food, music and a free bag of books for children 12 and under. At this special event, Bernie's Book Bank distributed 1,256 free books to empower children to explore new ideas, gain knowledge and strengthen reading skills. Bookapalooza was made possible by our partnership with the Back of Yards Neighborhood Council and generous sponsors.



2022 EVENTS

Bernie's Book Bank hosted hundreds of supporters at nine 2022 events to fund and share our mission. Bernie Cup 'Friend-raisers' engaged new players to enjoy top-tier courses while learning more about our organization and the children we serve. Our annual Birdies & Books Charity Golf Classic was the most successful to date, challenging players at Shoreacres and raising critical funds to provide quality books to Chicagoland children.

During our 3rd Annual Walk As One Chicago in September, walkers spent the day traversing the city to raise awareness and donations for Bernie's Book Bank in partnership with ESPN Chicago. A live broadcast, book distribution and first pitch at the White Sox game made this event one for the books! Our year culminated in the Patrick Mannelly Award where we celebrated the top collegiate Long Snapper for the 4th year. 
